





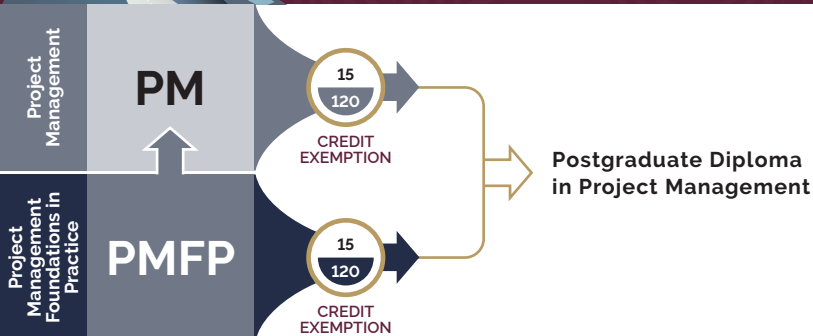

**Mode:** Blended

**Admission Requirements:** At the discretion of the institution

**Duration:** 1 year (Modular) or 2 years (Blended)

**Required:** Undergraduate degree

On successful completion of SBS-ED's Project Management and Project Management Foundations in Practice courses, participants can apply for exemption of **15 credits** towards the present curriculum of the Postgraduate Diploma in Project Management (NQF 8) offered at Stellenbosch Business School. Applying for credit exemption for the foundational phase of this PGDip is possible via the SBS-ED remote Project Management, and online Project Management Foundations in Practice courses, followed by the Advanced Project Management course.

**NOTE:** The Managing Projects module at Stellenbosch Business School forms part of the foundational modules for participants in the Postgraduate Diplomas in Project Management and Development Finance cohorts. It is also an elective for participants in the Postgraduate Diploma in Business Management.

**NOTE:** Successfully completing this programme does not automatically allow, nor guarantee acceptance on any degree programme of any partner institution, nor obviate the application process and admittance criteria. Applying for credit exemption must be exercised within 5 years of completing the programme.
